**Cash Bar:**

A cash bar is where your guests pay for their own drinks. We accept cash and credit cards. The following are provided with a cash bar service: bartender(s), glassware, ice, mixers, appropriate garnishes and basic bar supplies and tools.

**Open Bar:**

Open bar is where the host pays for all the beverages. Our bartenders track the purchase of each drink and settle up with the host at the end of the event. Host is required to pay a deposit and have a credit card number on file. Please review options on types of open bars offered below.
